



MEMORANDUM OF UNDERSTANDING BETWEEN UNIVERSITY OF VETERINARY AND PHARMACEUTICAL SCIENCES BRNO REPUBLIC OF CZECH

and UDAYANA UNIVERSITY, INDONESIA

This Memorandum of Understanding (MOU) is entered into by and between:

UNIVERSITY OF VETERINARY AND PHARMACEUTICAL SCIENCES BRNO hereinafter referred to as "UVPS" a public university, that is engaged in fields of veterinary medicine. veterinary hygiene and ecology, and pharmacy, having its registered office at Palackeho tr. 1946/1, 612 42 Brno, Czech Republic, represented by the Rector Prof. MVDr. Ing. Pavel Suchy, CSc. and shall include its lawful representatives and permitted assigns of the FIRST PARTY.

AND

UDAYANA UNIVERSITY hereinafter referred to as "UNUD", a state University, that is engaged in fields of education, research, and community services, having its registered office at Kampus Bukit Jimbaran, Bali, Indonesia, represented by the Rector, Prof. Dr.dr. A.A. Raka Sudewi, Sp.S (K) and shall include its lawful representatives and permitted assigns of the SESCOND PARTY.

Considering their common interest in promoting the mutual cooperation in the area of education and research:

Pursuant to the prevailing laws and regulations in their respective countries, as well as the procedures and policy of the Government Czech Republic and the Government of of Indonesia. HAVE AGREED as follows:

- Promoting the international academic cooperation in the field of.
 - Exchange of materials in education and research, publications, and academic information;
 - Exchange faculty and research scholars;
 - c) Exchange of students:
 - Joint research and meetings for education and research; d)
 - Technical assistance

Before these activities can be implemented, both parties shall discuss the problems involved to the satisfaction of each party and enter into specific activity agreements based on the mutually agreed objectives and outcomes of the relationship.





- This Memorandum of Understanding shall be applicable to educational and research organizations attached to each party.
- This Memorandum of Understanding constitutes the entire agreement between the parties, and all prior discussions, agreements, and understandings, whether verbal or in writing, are merged in this agreement.
- 4. This Memorandum of Understanding is not considered to be a contract creating legal and financial relationships between the parties. Rather, it is designed to facilitate and develop a genuine and mutually beneficial exchange process/research relationship, and so forth.
- This Memorandum of Understanding shall become effective as of the date of signatures of both parties. It may be amended by written consent of the parties.
- 6. This Memorandum of Understanding should be reviewed every four years to evaluate the progress and the quality of the mutual cooperation. It may be extended for additional four year period upon the written consent o both parties. If the Memorandum of Understanding is not renewed by mutual consent, then it will conclude at the end of specified time period, or after in progress have concluded.
- This Memorandum of Understanding may be terminated by either party with a minimum of 60 days written notice. Activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed.
- Both institutions subscribe to a policy of equal opportunity and will not discriminate on the basis of race, religion, color, sex, age, national origin or ancestry, material status, parental status, or disability.
