



MEMORANDUM OF UNDERSTANDING

between

CENTRAL MINDANAO UNIVERSITY (CMU)
and

UNIVERSITY OF UDAYANA (UNUD)



UNIVERSITY OF UDAYANA

CENTRAL MINDANAO UNIVERSITY at Musuan, Maramag, Bukidnon, Philippines represented by its President, **Dr. Maria Luisa R. Soliven, PhD** and **UNIVERSITY OF UDAYANA** at Kampus Bukit Jimbaran, Kuta Selatan, Badung, Bali, Indonesia, represented by its University Rector, **Professor Ketut Suastika, MD**, for the purpose of strengthening ties and promote academic and cultural exchanges between the two universities, hereby affirm their intent to explore the establishment of exchange programs and partnership in instruction, research and capability building.

The partnership between parties shall be carried out subject to availability of funds, facilities and experts, the approval of both parties, and based on mutual consideration through a variety of activities and programs such as:

1. Exchange of academic faculty/staff for purposes of teaching, research and capability building;
2. Exchange study/training programs for students;
3. Exchange study/training programs for faculty & staff;
4. Participation in joint seminars, lectures, trainings and academic meetings;
5. Partnership in research and extension projects; and,
6. Development and promotion of other academic cooperation as mutually agreed.

This MOU does not commit either institution to any prescribed course of action and shall not require expenditures or other commitments of resources by either institution. The cooperation described will be dependent upon the availability of necessary funds and resources, and approval of the respective institutions.

A detailed description of each activity mentioned above will be defined in a separate Agreement of Implementation, which shall be drawn up and agreed upon by CMU and UNUD. Any differing viewpoints and interpretations of this MOU shall be settled by negotiations.

This MOU shall be effective upon approval by both parties and shall remain in effect for an initial period of five years (July 2016 to June 2021) with the understanding that it can be terminated by either party with six months notice, unless an earlier termination is mutually agreed upon. Revisions, or modifications may be proposed at any time, effective from the date of the written agreement signed by both parties.

The signatures affixed below attest to the commitment of both institutions to the above paragraphs, as part of their respective commitment to the development of intellectual capital to its faculty and students, and to further foster international understanding, cooperation and goodwill.
